#### **1. REMOTE PARTICIPATION AND VOTING FACILITIES (“RPV”)**

Shareholders are to attend (including posing questions to the Board via real time submission of typed texts) and vote (collectively, “participate”) remotely at the AGM using RPV provided by UCrest Berhad (“UCrest”) via its Cisco Webex via the link <https://ucrestagm.webex.com/ucrestagm-en/onstage/g.php?MTID=e6a39aeac210ed2e270bf476b8efad477>.

Shareholders who appoint proxy/proxies to participate via RPV in the AGM must ensure that the duly executed proxy forms are deposited in a hard copy form to the Share Registrar no later than **Wednesday, 10 November 2021 at 11.00 a.m.**

Corporate representatives of corporate members must deposit their original certificate of appointment of corporate representative to the Share Registrar not later than **Wednesday, 10 November 2021 at 11.00 a.m.** to participate via RPV in the AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Share Registrar not later than **Wednesday, 10 November 2021 at 11.00 a.m.** to participate via RPV in the AGM.

**A shareholder who has appointed a proxy or attorney or authorised representative to participate at this AGM via RPV must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at Cisco Webex at the following link:**

(c)	Login to Cisco Webex	<ul style="list-style-type: none"><li>• If you don't have Cisco Webex, please download before 24<sup>th</sup> AGM start.</li><li>• Click join event which was provided to you via e-mail any time from 10.45 a.m. The live streaming will commence at 11.00 a.m. on 12 November 2021.</li></ul>
(d)	Participate through Live Streaming	<ul style="list-style-type: none"><li>• Click join event to engage in the proceedings of the AGM remotely.</li><li>• If you have any question for the Chairman/ Board, you may use the Q&amp;A box to transmit your question. The Chairman/ Board will try to respond to relevant questions submitted by remote participants during the AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li></ul>
(e)	Online Remote Voting	<ul style="list-style-type: none"><li>• Member or Proxy may commence voting <b>from 11.00 a.m. on Friday, 12 November 2021</b> until a time when the Chairperson announces the completion of the voting session of the AGM.</li><li>• Indicate your voting for the resolutions that are tabled for voting.</li><li>• Confirm and submit your votes.</li><li>• Upon completion of the voting session for the 24<sup>th</sup>AGM, the Scrutineers will verify the poll results, followed by the announcement by the Chairman of the poll results.</li></ul>
(f)	End of remote participation	<ul style="list-style-type: none"><li>• Upon the announcement by the Chairperson on the closure of the 24<sup>th</sup> AGM, the live streaming will end.</li></ul>

**Note to users of the RPV facilities:**

1. Should your application to join the meeting be approved we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to **Cisco Webex** on the day of meeting will indicate your presence at the virtual meeting.
2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

**3. ENTITLEMENT TO ATTEND AND VOTE**

If you wish to personally participate in the 24<sup>th</sup> AGM, please do not submit any Proxy Form. You will not be allowed to participate in the 24<sup>th</sup> AGM together with a proxy appointed by you.
